This is a true copy with arithmetic errors and miss-spellings retained. At the time this data was copied, October 2009, my interest was mainly in the lockkeepers' names, Cumberland Division. Recently interest has been expressed in the names of all the Canal Company employees, all along the line. Another trip to the National Archives will be necessary to copy the remaining data; then this file will be revised. That trip is unscheduled. It is to be remembered that all of these men were Canal Company employees.
